

Introduction

Colwich Parish Council covers the villages of Colwich, Little Haywood, Great Haywood, Wolseley Bridge and Bishton. The Council has 14 members, elected every four years, who are split between the two wards of Little Haywood / Colwich and Great Haywood. The council employs two members of staff, the Parish Clerk and the Assistant Parish Clerk.

The Full Council meets at 7:30pm on the first Thursday of every month with the Neighbourhood Plan; Environment & Leisure and Policy & Resources Committees meeting on the subsequent Thursdays every month with a quarterly Newsletter Committee meeting. The Council also holds Planning Committee meetings to discuss major planning applications. Meetings are open to the public who may raise questions and concerns on any item on the Agenda.



Jubilee Playing Fields

The Parish Council owns and maintains the sports field, toilet block and play area. The Council has now



provided through DT Leisure a Multi-Use Games Area, Skateboard Park and Youth Shelter. There are plans to provide a BMX track and tarmacked footpath in the financial year 2015/16.

The Council lets a contract each year for the maintenance of the toilet

block at the JPF. This contractor also ensures that the play area and recycling area are kept clear of litter and hazards. This contract is advertised annually in early Spring.

Allotments

The Parish Council owns 3.7 acres of allotments, on Coley Lane, which it leases "en masse" to the Allotment Society who manage and operate the site. Demand is high and the waiting list for plots is growing. With this in mind, the Council continues to

investigate other possible sites for allotments within the Parish.

Parish Maintenance

A contract is awarded annually to a 'lengths man' who looks after the open areas and flower beds that are the responsibility of the Parish Council. The lengths man helps to keep the village looking neat and tidy, working closely with the Best Kept Village Committee and the Parish Clerk. He also undertakes any small repairs or other jobs that may be required. This contract is advertised annually in Spring.

Local Government Awards Scheme

Colwich Parish Council currently holds Foundation status under the new Awards Scheme launched in 2015 and is working towards Quality status.





Newsletter

Footpaths

The Parish Council works in conjunction with Staffordshire County Council to investigate and resolve issues regarding rights of way including broken stiles or missing signs





Highways

The Community Highways Gang from the County Council is given a list of work to undertake in the parish, based on comments and requests from residents and the council.

All grit bin requests are forwarded on to the Highways Department at Staffordshire County Council. They assess the site using set criteria before deciding whether to install one or not.

Agency Services

Staffordshire County Council pays the parish council a sum of money each year to cut grass and clear drains and footpaths on their behalf.



Neighbourhood Development Plan

The Parish Council continues to progress the Neighbourhood Plan for the Parish. This is part of the new Localism Act which has been designed to give local communities more power to influence and shape services and developments in their area. A local Consultant has been brought in to aid the Council in the development of the Plan. A number of Public consultation events were held during the year including the Open Gardens in July and various school events. The Plan will reintroduce settlement boundaries around Great Haywood and Little Haywood / Colwich. Once completed and passed via independent inspection and a public referendum, the Neighbourhood Development Plan will have to be considered by planners when making decisions or recommendations on planning applications in the parish.

Planning

The Parish Council is a statutory consultee for planning applications. The Planning Committee meets when a major planning application is received. The Parish Council does not have the power to make a decision on planning applications but can raise objections or concerns for consideration. These are returned to Stafford Borough Council along with any noticeable infringements on planning regulations.

Administration

The Parish Clerk has successfully achieved the Certificate in Local Council Administration, a vital element needed for the



Council's continued involvement in the Local Government Awards Scheme.

Grant and funding assistance applications are considered by the Policy & Resources committee who have a budget of £2,075. Payments made during the year 2014-2015 are as follows:



FINANCE

The main form of income for the Parish Council is the precept demand which is included in the council tax from Stafford Borough Council. Stafford Borough Council also makes a payment to the Parish Council (called a concurrent function) every year which is used towards tasks undertaken by the Parish which mirror those that the Borough undertake in Stafford e.g. cleaning public toilets. In addition to the Precept, Stafford Borough Council has passed on the Government's Local Council Tax Support Grant amount of £5,220. These amounts are expected to be similar in 2015/2016.

Although it is the Borough Council that charges the council tax, it includes payments for the Police, Fire & Rescue Service, Staffordshire County Council and the Parish Council as well as for the Borough itself.

Colwich Parish Council has maintained the level of its precept demand for the year 2014/15 at £72,720 which is the equivalent of £44.77 for a Band D property.
