# Introduction

Colwich Parish Council covers the villages of Colwich, Little Haywood, Great Haywood, Wolseley Bridge and Bishton. The Council has 14 members, elected every four years, who are split between the two wards of Little Haywood / Colwich and Great Haywood. The council employs two members of staff, the Parish Clerk and the Deputy Parish Clerk.

The Full Council met at 7:30pm on the first Thursday of every month. The following committees also met during the year: Neighbourhood Plan; Environment; Leisure; Policy; Finance; Employment; Newsletter; Allotments; Young People and Burial. The Council also held Planning Committee meetings to discuss major planning applications. Meetings are open to the public who may raise questions and concerns on any item on the Agenda.

The Parish Centre is open between 10am and 3pm, Monday to Friday. As well as information leaflets, the office also has a store of free dog poop bags, provided by the Borough Council.

# The Ordinary Election for the Council.

Both wards had contested elections, held for the first time on the same day as the General Election. In the Great Haywood ward, there were ten candidates for its seven seats, whilst for the Colwich / Little Haywood ward there were eight candidates.



# **Jubilee Playing Fields**

The Parish Council owns and maintains the sports field, toilet block and play area. The Council has now completed the work started in 2014 with the installation of a BMX track and tarmacked footpath.

The Council lets a contract each year for the maintenance of the toilet block at the JPF. This contractor also ensures that the play area and recycling area are kept clear of litter and hazards.



During the year, the Council installed a network of CCTV cameras at the JPF to protect the integrity of the site, not least the new play equipment. Following fly-tipping over the Christmas period, together with other incidents of anti-social behaviour, the Council installed a further two cameras covering the recycling area and the skateboard park/youth shelter. These cameras record high resolution full colour

images from across the park with integrated night vision capability. The images can and have been shared with Stafford Borough Council for fly-tipping and dog fouling and with Staffordshire Police for incidents of anti-social behaviour and vandalism. The Council will always push for a prosecution as it strives to eliminate this behaviour and to protect the JPF for all residents to enjoy.

#### Allotments

The Parish Council owns 3.7 acres of allotments, on Coley Lane, which it leases "en masse" to the Allotment Association who manage and operate the site. Demand is high and the waiting list for plots is growing. With this in mind, the Council continues to investigate other possible sites for allotments within the Parish.

### **Parish Maintenance**

The Parish Council is responsible for various grass areas in the Parish under agreements with the Borough and the County councils. These grass verges are currently maintained through contracts with the Council by Trent Ground Maintenance and Weston Grounds Maintenance.



#### **Footpaths**

The Parish Council works in conjunction with Staffordshire County Council to investigate and resolve issues regarding rights of way including broken stiles or missing signs

#### **Highways**

The Community Highways Gang from the County Council is given a list of work to undertake in the parish, based on comments and requests from residents and the council.

All grit bin requests are forwarded on to the Highways Department at Staffordshire County Council. They assess the site using set criteria before deciding whether to install one or not. The Parish Council continues to progress the Neighbourhood Plan for the Parish. During the year the Neighbourhood Plan has passed numerous milestones including a six week consultation by the Parish Council followed by a further six week consultation by the Borough Council. The Plan was then sent for independent external examination and the comments received from the examiner used to redraft the plan. The Plan has now been formally submitted to the Borough Council, requesting that they arrange a referendum of the parish electorate. The date of the referendum is still awaited.

# Planning

The Parish Council is a consultee for planning applications. The Planning Committee meets when a major planning application is received. The Parish Council does not have the power to make a decision on planning applications but can raise objections or concerns for consideration. These are returned to Stafford Borough Council along with any noticeable infringements on planning regulations.

# Administration

The parish is managed by a fulltime Parish Clerk / Responsible Financial Officer and a part-time Deputy Clerk / Financial Officer.

Four Newsletters are published each year.




#### **FINANCE**

The main form of income for the Parish Council is the precept demand which is included in the council tax from Stafford Borough Council. Stafford Borough Council also makes a payment to the Parish Council (called a concurrent function) every year which is used towards tasks undertaken by the Parish which mirror those that the Borough undertake in Stafford e.g. cleaning public toilets. In addition to the Precept, Stafford Borough Council has passed on the Government's Local Council Tax Support Grant amount of £5,220. These amounts are expected to be similar in 2016/2017.

Although it is the Borough Council that charges the council tax, it includes payments for the Police, Fire & Rescue Service, Staffordshire County Council and the Parish Council as well as for the Borough itself.

Colwich Parish Council had made a small reduction in the level of its precept demand for the year 2015/16 at £72,720 which is the equivalent of £44.30 for a Band D property.
