## YOUNG PEOPLE'S SURVEY AWARDS

Three young parishioners were rewarded for their contribution to the Neighbourhood Plan at ceremonies at the Parish Centre. Jack Rivers won the £75 top award. The second prize of £50 of vouchers went to Oliver Share and the third prize of £25 vouchers went to Scott Rattray.

In spite of help from the Rangers and the schools the Parish Council had found it difficult to get much response to the Neighbourhood Plan from young people. This was a pity because they are the people who will grow up in a Parish that will be shaped by the Plan. The Parish Council's response was to distribute a survey around the Parish and offer awards to the first three contributors whose names were drawn from a hat.

Cllr. Gilbert said, 'We are most grateful to these enthusiastic young people for helping us to develop the activities they really want in the community. They have also added useful information to our Neighbourhood Plan which will be a long term benefit to the villages and hamlets throughout the whole parish'.



Colwich Neighbourhood Plan will set out how the Parish will develop, including how to preserve the character of the area, where new homes could be built, and how to protect local green spaces. Colwich Parish Council had asked local young people to fill in a survey about local recreation facilities.

Jack Rivers was awarded a £75 voucher by Council Chairman, Cllr Paul Gilbert.

Oliver Share received a £50 voucher whilst Ally Rattray accepted a £25 voucher on behalf of her brother Scott from Cllr Gilbert in a ceremony attended by Parish Councillors and volunteer members of the neighbourhood Plan Committee.

# JUBILEE PLAYING FIELDS UPDATE

#### **PLAY EQUIPMENT**

For some time, the Parish Council has been looking to develop the facilities on the Jubilee playing Fields (JPF) for additional play equipment to cater for an older age range of young people who have grown out of the existing play equipment.

Surveys and other communications have indicated a definite requirement within the Parish, so the council has actively sought to install a Multi-Use Games Area (MUGA), skateboard park and BMX racing track. The project has taken a lot longer than was originally anticipated, due to the input required from the ongoing Neighbourhood Plan, problems with the initial potential supplier, determining whether or not planning permission is needed (unbelievably difficult getting a definitive answer from the Borough's planning officials) as well as trying to determine what grant aid might be available! The good news is that hopefully there is light at the end of the tunnel for this project, with a new supplier on board and construction work currently scheduled for the 1st November this year. If all goes to plan, then we should see the equipment in place by the end of the year and hence ready for serious use during 2015 as the seasons improve!

## UNUSED BUILDING AND TOILET BLOCK

As has been suggested in previous editions of this Newsletter, the Parish Council has also been exploring the possibility of converting the existing unused JPF building into a more centrally located Parish Office and meeting room. An architect has been employed to submit drawings for the planning application which is now in process. Assuming this is successful, then working drawings will be produced to enable quotes for the work to be obtained.

# **BEST KEPT VILLAGE**




There will be a QUIZ NIGHT at Little Haywood Village Hall on Friday 10th October at 7.30 p.m.

- Leaving a fire to smoulder remember to douse it with soil or water.

# BUS SERVICES CHANGES

Regular bus users will now have noticed the changes – hopefully for the better - to the bus services connecting our Parish. The most obvious change is the additional red buses provided by D&G. The Parish Council were able to discuss the changes with Chris Almond of D&G at a meeting in July. The impression given to the Council by Chris was of a high level of commitment and customer focus from the new provider. Key points Chris was able to highlight included:

- The revamped 841 timetable was proving successful with Staffordshire County Council supporting a new route on school days.
- The 842 route will connect both ends of the Parish with Rugeley.
- A 'Joint Ticket' can be purchased connecting the new service with Midland Classic and Select services from September.
- New/improved vehicles with free Wi-Fi.
- More bus stops are being considered.
- D&G are happy to promote a service in rural areas where passengers can flag a bus down even when it is not at an official stop and, providing it is safe to do so, the bus will stop.

Another key point is the 'real-time' passenger information available via an 'app' for a smart phone, or by connecting to www.dgbus.co.uk. Passengers can also call the company via 01270 252970.

## **CHAIRMAN'S REFLECTIONS**

# The Seabridge Scourge is Back

Mr Seabridge has resubmitted a planning application for the land situated off Little Tixall Lane and lies at the rear of Marlborough Close.

The Leader of the Borough Council Cllr. Heenan, after failing to file his interests earlier this year has found time, through his company Inglewood Investments, to conduct a consultation exercise for a housing development on land adjoining the A51 off Little Tixall Lane. I am still waiting for the howls of opposition from his fellow councillors about this proposal - we may have to wait some time. I have no doubt that the planning committee vote it through.

To add insult to injury, the "Greenacres" developer has submitted a revised plan to include additional houses to the original application. With the HS2 viaduct virtually in the back gardens of this development the private sales on this development could be non-existent and the area will be turned into a social housing ghetto.

The developers have been assisted in their ambitions by Stafford Borough Council's planning department and its councillors. Developers are allowed to build anything and anywhere within KSVs (Key Service Villages) regardless of the destruction to the established village way of life within those communities.

# At present we have had the following developments to contend with:

The land adjacent to Greenacres – courtesy of the Deakins and the Mynors, Nursery Way, who will be content to bring about more problems by allowing the sewage from the Greenacres site to be pumped through the existing Nursery Way station increasing the capacity by 150%.

Land behind The Ring – courtesy of Mr Seabridge.

Land at Little Tixall Lane and at the rear of Marlborough Close – courtesy of Mr Seabridge and Mr Astle, Dobree Close. Some people can never have enough.

Shenley Cottage and land surrounding it – courtesy of the Moore Family Trust, we know that these people have been spending thousands to develop this land. Jeremy Lefroy has written a letter of objection supporting our efforts to prevent this development. Thank you and well done Jeremy!



As we all know, from past experience, financial gain supersedes conscience and integrity which is a true reflection of all those above.

I have no alternative agenda or any financial interests in these proposed and approved planning applications and I shall endeavour to safeguard your interests both now and in the future.

I shall shortly be having a meeting with our legal advisors to discuss the way forward on all the planning applications previously referred to. The council is seeking to co-opt representatives from the immediate areas affected by these planning proposals in order to exchange views and disseminate information quickly and accurately. Representatives will also be invited to attend meetings with our legal team.

We have co-opted one representative, to stand against the Seabridge Development on the land behind The Ring, and would invite requests/nominations from representatives opposing the other development areas.
