5. Area at Colwich bridge (SBC have included Church Farm).

RESOLVED to go with Colwich's green line. (Area believed to be part of the conservation area).

6. Area at Cliff Road. SBC and Colwich Parish Council agree on land at Cliff Road. The Council differs with SBC about land which is part of the triangular site north of Lt. Tixall Lane. The Council has truncated that area, whereas SBC includes the whole site.

RESOLVED to go with the SBC site.
