The Chairman then gave more detail on topics such as Planning, the Key Issues identified through the various consultations and the Vision and Objectives that had emerged from these.

Cllr Gibson then gave a presentation on the Policies and Proposals contained within the Plan namely: Economy/Businesses; Transport; Community and the Environment.

Mr Blount gave a presentation on the rationale behind the proposed Site Allocations, Sustainable Development and the Proposals map. Mr Blount then gave a breakdown of the consultation process both to be undertaken locally and upon submission to Stafford Borough Council ahead of the independent examination and the eventual referendum of all the electorate,

The Chair then invited comments and questions from the floor. H Jenkinson asked whether groups respond or is it only for individuals. The Chairman said either is welcomed. C Dewsnap asked about the land east of the railway and the possible floods. The Chairman said the Council is aware of the flooding issues and has discussed this with potential developers who have claimed this is not insurmountable.
