64/19 CHAIRMAN OF THE PARISH COUNCIL 2019/2020.

Cllr Dunn, as the Chairman at the end of the 2018/19 session, called for nominations for Chairman for 2019/20.

Cllr Billingsley was **PROPOSED** by Cllr Bloor and **SECONDED** by Cllr Whitfield.

Cllr Dunn was **PROPOSED** by Cllr Rattray but declined to stand.
