#### **MINUTES**

**30/19EL APOLOGIES** were received from Cllr Harris; B Broome; V Powell (Allotments Association); A Hardwick (Colwich Parish in Bloom); and S Collins (Plastic Free Colwich and the Haywoods).

#### 34/19EL REPORT FROM THE ALLOTMENTS ASSOCIATION.

i) The allotments are full at present with 10 names on the waiting list.

- ii) The Association raised £332.00 for Katherine House charity during the Open Gardens open day.
- iii) During early July there was a spate of minor thefts and vandalism, but this seems to have now died off.

A question was raised on the progress with (i) a site visit regarding works detailed in the arboriculture report; (ii) possibility for the lengthsmen to maintain hedges and borders /lane around site and (iii) Risk Assessment. In cases (i) and (iii) we are awaiting report from the organisation concerned and in case (ii) a quote is still awaited.

### 42/19EL COLWICH IN BLOOM ACCOUNT WITH A LOCAL NURSERY/GARDEN CENTRE.

**RESOLVED** to set up a Colwich in Bloom account with Roseacre Nursery.

**PROPOSED** Cllr Whitfield **SECONDED** Cllr Billingsley. On being put to the vote, the **RESOLUTION** carried unanimously

#### 36/19EL REPORT FROM THE PLASTIC FREE COLWICH PROJECT.

The name has now been changed to Plastic Free Colwich and the Haywoods. The Green Drinks evening has now built up to 30 attendees at the last evening. The next event will be held on 1<sup>st</sup> October 2019 when Becky Martin from Stafford Borough Council will speak about green issues. This will be followed in November by "Green up our Christmas" and in December by a social and perhaps a quiz. Details for the latter two events are to be announced. In the latest project, a Plastic Free packaging and buying scheme has been set up with items being ordered on line and delivered every Wednesday morning to the Lamb and Flag in Little Haywood.

### 38/19EL PURCHASE ADDITIONAL WASTE BINS FOR THE PARISH AND WHERE TO LOCATE THEM BASED ON THE RECENT SURVEY.

**RESOLVED** to approach land owners for areas by (i) School Lane, (ii) Little Tixall Lane, (iii) Coley Lane by Manor Farm Road and (iv) Essex Bridge where permission may be required to see if they will allow bins to be placed in these areas. Clerk to write to land owners by November Full Council meeting requesting permission.

**RESOLVED to** purchase extra bins for the above areas if permission has been given (where required).

**PROPOSED** Cllr Billingsley **SECONDED** Cllr Bloor. On being put to the vote, the **RESOLUTION** carried unanimously.

### 39/19EL THE ELMS BUSINESS PARK.

It was noted that the landowner has now cleaned up this area.

## 40/19EL THE CHAIN LINK FENCE ON THE OLDFIELDS CRESCENT GRASS AREA.

**RESOLVED** to remove the chain link fence on the Oldfields Crescent grass area and clean up the area behind the fence.

**PROPOSED** Cllr Billingsley **SECONDED** Cllr Bloor. On being put to the vote, the **RESOLUTION** carried unanimously.

## 43/19EL TO CONSIDER AND AGREE PURCHASING SMARTPHONES FOR USE BY THE CLERKS AND LENGTHSMEN.

**RESOLVED** to agree in principle to purchase either mobile or smartphones for the clerks and lengthsmen, but, before purchase, the clerk is to produce a paper putting forward the business case as follows:

- i. To justify whether purchase should be for smart phones or basic mobile phones
- ii. To confirm whether a phone is required for one or more lengthsmen
- iii. To look into best contracts and network coverage.

The paper should be presented to Full Council for the November meeting, if possible.

**PROPOSED** Cllr Billingsley **SECONDED** Cllr Whitfield. On being put to the vote, the **RESOLUTION** carried unanimously.
