VE-DAY BEACON LIGHTING

On Thursday 8th May 2025, the village came together to commemorate the 80th anniversary of VE day, the end of the 2nd world war in Europe.

The formal evening commenced at 8.45pm, with a welcome from Cllr Wendy Plant, Chairman of the Council, which was followed by a blessing from Revd Mark Davys.

As per the guidance issued by the Royal Pageantmaster, Bruno Peek, the hymn 'I vow to thee my country' was sung. The beacon was lit at 9.15pm, after bugler Anita Small had played the last post and reveille, including the 2 minutes silence, and the National Anthem.

Throughout the evening, Fish & Chips (JMA catering) and Thai food (Thai2go) were available to purchase.

On Sunday $11^{\rm th}$ May, St Stephen's held a church service to commemorate the VE day anniversary.

There will be a similar event at the JPF on the 15th August to commemorate the 80th Anniversary of VJ day.











SUMMER FETE

The fourth annual village fete took place at the Jubilee Playing Field on Saturday 21st June 2025 between 12.00 noon and 11.00 pm.

The afternoon was due to start with a dog show, but due to the heat forecast, it was determined to be too much of a risk and was cancelled. Instead, the fete began with a short speech by Chairman of the Council, Cllr Wendy Plant, and a blessing by Revd Davys followed by a collection of songs from the community choir.

The entertainment continued with performances by Delta Aces, a Staffordshire based blues duo, and Boat Band, an instrumental folk quartet. The afternoon concluded with a lively vintage set from local star Lola Lamour.

Throughout the afternoon there were a collection of local stalls, and activities.

This year, the council introduced a £3 children's entertainment wristband, allowing unlimited access to activities such as: spinning teacup ride, toy carousel ride, climbing wall, tomahawk throwing, and table football. The charge will help to offset some of the cost of hiring the activities for the event.

The Council also ran a music themed scavenger hunt throughout the event. Entrants were challenged to find the 9 number 1 hits from each decade between 1945 & 2025, which were posted at points around the fete. All entrants received a sweet upon returning their completed forms.

During the swap over period, Vibe1 hosted a disco. Vibe1's Stu Haycock, acted as compare for the day.

The evening entertainment was a mixture of new faces, and familiar friends. At 6pm, we began with a set from Captain Fantastic, an Elton John tribute act. Next was the Staffordshire Rock Choir, a group from all over the county. Our last act of the evening was Skabucks, a fan favourite ska and two-tone group. As the fete wound down, OSB (who provided the stage and sound system) played a set of Ibiza tunes.

Out of our original 5 food vendors, only two made it to the end of the fete. We had two cancellations with short notice, and the Fish and Chip van left early unexpectedly. La Piccola Pizzeria completely sold out of food by early evening, and Carney's hog roast was not far behind. The pitch fees for food vendors will be used to partly offset the cost of the music entertainment.

Money raised from community pitch fees and donations, will be donated to our two charities of the year. In 2025 we selected Troop Aid, and Hixon and Area Community First Responders, both of whom had stalls at the fete.

Throughout the year there will be more opportunities to raise funds for our charities, like the competitions we put on, and our Christmas Light Switch On.












LEN GTHSMEN

The Lengthsmen have been very busy since our last Newsletter in the spring. Work moved from the usual winter maintenance works onto the annual grass cutting programme. The Lengthsmen manage the grass verges near Roseacre, Oldfields Crescent, Essex Drive, Abbeyfields, Elm Close, Trent Square, The Butts, Parish Office, Hawkesmore Drive, Haywood Grange, Dobree Close, A51 junction at Colwich and Kingfisher Drive. Additionally, the Lengthsmen maintain JPF field and the Garden of Remembrance. Following the completion of the refurbished St Marys play area, the Lengthsmen have begun looking after the grass areas under agreement with Stafford Borough Council. The early warm and wet weather meant that the grass grew quicker than usual in the spring. Consequently, the Lengthsmen reacted seamlessly to this increase by moving from fortnightly to weekly cuts. The Lengthsmen have also undertaken work on Essex Bridge to clear the vegetation and have now completed the task of cleaning the sandstone bank along Coley Lane.

During June, the Lengthsmen concentrated on preparing the JPF ahead of the annual village fete, reported elsewhere in this Newsletter. The Lengthsmen also assisted in stewarding the fete, working from earlymorning to after 11pm, alongside Councillors, the Chief Officer, Events Officer and Nicki the cleaner.

Work continued on the Garden of Remembrance, off Coley Lane, especially in preparation for taking part in the Open Gardens event on 6th July. The Lengthsmen have installed numerous plaques and planted additional trees, including special ones purchased by residents to accompany their plaque. Additional plaques are under order from the manufacturers with lots of trees still available if you would like a plaque (costing about £95 plus carriage and VAT). The Lengthsmen have cut various routes through the grass giving straight pathways along the east and west of the field as well as gentle zig-zagging ones down the slope. The Lengthsmen have placed six benches in the field of which five are available for dedication plaques on contacting the Chief Officer. The Council is working with its architect seeking planning permission for a small carpark on the south-east of the site as well as provision to install a hardstanding pathway, in due course.

When visiting the field, we would ask you to respect the privacy of the residents of Hillview Grove, especially Mr & Mrs Green who own the land over which the public right of way, CP45, runs.

INSURANCE - WHY HAVE IT?

Public Liability Insurance is a type of insurance that protects against claims for injury or property damage to third parties (members of the public, clients, or customers) caused by your activities. It covers legal fees and compensation costs if someone sues you for an incident occurring on your premises or related to your work or activity.

While not legally required, it's crucial for organisations that interact with the public, as it can safeguard against unforeseen costs and potential legal battles. If your organisation does not have public liability insurance, then the management group, e.g. Chairman; Vice Chairman; Secretary and Treasurer etc., will be personally responsible for covering legal fees and any compensation costs if a member of the public makes a claim against your organisation for injury or property damage. This could be a substantial financial burden.

The Council's insurance cover provides £10,000,000 Public and Products Liability Insurance.

Consequently, whenever we work with outside groups, e.g. contractors for works or stall holders for the village fete, we insist that they provide copies of their Public Liability Insurance.

The National Council for Voluntary Organisations' (NCVO) website notes that employers in Great Britain have a duty under the Employers' Liability (Compulsory Insurance) Act 1969 and Employers'

Liability (Compulsory Insurance Regulations) 1998 to

have employers' liability insurance for no less than £5m. This insurance must cover liability for accidents, disease or injury to an employee due to negligence or breach of health and safety law by the employer. Employees, workers, apprentices and some trainees must be insured under this cover, but there is no duty

to insure volunteers. If volunteers are found to be working under a contract they would be seen by law as employees and workers.

The NCVO accepts that this legislation doesn't force

organisations to insure volunteers. However, they advise that they do so in case negligence cases are brought by volunteers. Consequently, they recommend that organisations make sure that volunteers are covered by their employers' liability insurance, or under similar terms in their public liability policy, and that they specifically notify their insurer that they work with volunteers.

The Council's insurance provides £10,000,000 Employer Liability Insurance.

THE TOLKIEN PROJECT

The Tolkien Project aims to commemorate and celebrate the connection between the Parish of Colwich and the world-famous author, J. R. R. Tolkien. It is a joint enterprise by Colwich Parish Council, Great Haywood Memorial Hall, the Great War Commemoration Committee, and the Haywood Society. In 1916 Tolkien was stationed at Brocton Camp on Cannock Chase, from where he walked through Shugborough Park to visit his newly married wife, Edith, in Great Haywood. After the Battle of the Somme, Tolkien convalesced in Great Haywood for almost three months and here he wrote the first stories of his 'Mythology for England', The Book of Lost Tales, which led later to his much celebrated and much-loved Lord of the Rings.

While much attention has been given to the influences of his early life in Birmingham, Oxford and Warwick, his early writings were clearly influenced by this area – the walk from Little Haywood to Great Haywood (the arrival of Eriol in Tavrobel in *The Cottage of Lost Play*), the village of Great Haywood (*Tavrobel*), Essex Bridge (*the Grey* Bridge of Tavrobel), the rivers Trent and Sow (the Gruir and the Afros) and Shugborough Hall (the House of a Hundred Chimneys), as well as several features of Cannock Chase.

It is planned to mark the connection with a prominent Information Board providing details of the Tolkiens' time here, a Direction Post indicating places where the Tolkiens stayed or that influenced the author's writings, Blue Plaques on buildings associated with the Tolkiens, and a booklet The Tolkien Trail, Walks In and Around Great Haywood in the Footsteps of J. R. R. Tolkien. It is hoped that the project will enhance the literary image and reputation of the Parish, promote Tolkien tourism in accordance with the Colwich Parish Neighbourhood Plan and attract people to local businesses and other visitor attractions.
