

MINUTES OF THE PLANNING COMMITTEE MEETING HELD ON MONDAY 10TH JULY 2023 AT THE PARISH CENTRE, ST. MARY'S ROAD, LITTLE HAYWOOD, COMMENCING AT 7.30 PM.

The Chairman invited Helen Royall to speak to the Shugborough planning application. Shugborough propose changing the main entrance into the estate from Stafford Drive, Milford, in the southwest of the estate, to a reinstated Lichfield Drive, on the southeast of the estate. Stafford Drive will be retained as an access for pedestrians and cyclists as well as for emergency vehicles. A new visitor centre, offices, toilets, and cafe will be built along with the relocation of the main visitor carpark. The carpark at the mansion will be reduced. Discussions have been held with County Highways about the impact on the A513, including widening and the installation of a right turn lane at the new entrance.
